Hamilton Township Trustee Meeting

April 20, 2022

Trustee Board Chairman, Joe Rozzi, called the meeting to order at 6:00 p.m. Mr. Rozzi, Mr. Sousa and Mr. Cordrey were present.

The Pledge of Allegiance was recited by all.

A motion was made by Mr. Rozzi with a second by Mr. Cordrey to approve of the clerk's journal and accept the tapes as the Official Meeting Minutes of the April 7, 2022 Trustee Meeting.

Presentations

Fire Chief, Jason Jewett, introduced five firefighters: Matthew Leeper, Adam Gilpin, Matthew Cunningham, Jacob Spears and Abbie Muterspaw.

Chief Jewett read the Oath of Office to officially swear in the new hires as full-time members of the Hamilton Township Fire Rescue. A round of applause was given by all.

Police Chief Scott Hughes presented two patrol officers: Officer Shelby Davis and Officer Shawn Parks.

Chief Hughes delivered the Oath of Office to formally swear in the new hires as full-time officers of the Hamilton Township Police Department.

After a second round of applause, Mr. Rozzi called a brief recess.

Public Comments

Mr. Rozzi opened the floor to public comments at 6:18 p.m.

Mr. Dan Crombie and Ms. Luanne Cain expressed their concerns about the construction progression of the mosque and the egress positioning.

Mr. Hickey gave assurance that Ms. Gehring (Zoning Administrator) had been in contact with the Warren County Water and Soil Department and was closely monitoring the situation.

Mr. Crombie questioned why the access points were not moved and asked who would be responsible for bonding.

Mr. Weber, in consensus with the trustees, responded that access points relating to state routes were not under the township's jurisdiction. Instead, they were authorized by ODOT (Ohio Department of Transportation). In addition, Mr. Weber pointed out that bonding on proposed state road improvements would likewise be handled by ODOT. He also mentioned that any soil or water improvements, erosion control, earth disturbance would be controlled by soil and water conservation.

Mr. Sousa announced they would check with the community partners to ensure compliance.

Mr. Brodi Conover, Assistant Law Director, guaranteed that the township would be swift in enforcing zoning infractions if warranted.

The trustees reminded the residents to communicate their findings to the township administration and kindly requested ample time for them to take action on any future issues that should arise.

At that point, Mr. Marvin Stotz stepped forward to question the legalities of bonds and inquired about asphalting.

Mr. Hickey mentioned that he would check into his inquiries.

The conversation then shifted to the community garden. Mr. Stotz asked about the community garden's status.

Mr. Sousa responded that the garden not was situated in an ideal location. He also noted they had received a number of complaints from residents regarding the garden. Mr. Sousa gave assurance that once a new location was sought it would be a better solution for the township as a whole.

Mr. Rozzi closed the floor to public comments at 6:48 p.m.

-Motion: Memorandum of Understanding with the Patrol Officers and the Police Clerk Contracts

Police Chief Hughes explained this would be a simple update of the FOP contract to include the Juneteenth holiday.

-Motion: To enter into contract with KZF Design for the Fire Training Tower

Fire Chief Hughes noted this would be the design criteria architect for the Fire Training Tower to be built on Nunner Road in Marr Park. KZF would oversee the specifications and construction. They would also be responsible for monitoring the project, providing legal language and ensuring the design criteria is communicated to the companies needing proposal requests.

Mr. Cordrey inquired about the tower's completion timeline.

Chief Jewett answered that it would depend on supply chain issues, but the projected goal would be November 1st.

Mr. Sousa asked for clarification. He surmised that the group would partner with the township by ensuring it would be completed as planned to protect both Hamilton and Deerfield Townships' financial interests.

Chief Jewett affirmed Mr. Sousa's conjecture.

-Motion: To enter into contract with Eco Development

Mr. Hickey explained this contract would be a cost saving initiative for lighting in the administration building.

Mr Cordrey asked about the length of warranty with this plan.

Mr. Hickey replied there was a five year warranty for both the bulbs and the fixtures.

Mr. Sousa stated he requested Mr. Centers to get a few referrals on the vendor. In doing so, the cost savings were found to be accurate (return interest in 2.96 years from project completion). In addition, he expounded on the cost and the long term savings of the project (approximately \$39,000 with an estimated savings of \$1000 per month).

Furthermore, Mr. Hickey commented that the new bulbs would be LED lighting, which tend to last longer and be more efficient than the current fluorescent bulbs currently installed in the building.

Mr. Rozzi made a motion to enter into contract with Eco Development for lighting upgrades in the administration building.

Fiscal Officer's Report

Fiscal Officer, Mr. Kurt Weber, reviewed the financial report for the month of March. At 25% thru the year, 6.4% of the estimated revenue was received. Approximately 20.6% of the expenditures was spent. The overall total cash balance was around \$13.5 million.

Administrator's Report

Mr. Hickey asked for direction on the purchase of the handheld portable radios.

Mr. Sousa inquired if the portable radios that are currently in use would have any market value once replaced or if they would be obsolete and donated equipment.

Mr. Hickey answered that most of the time they would become obsolete, but indicated he would check into it. He noted there would be a considerable cost savings if the radios were purchased this year opposed to waiting until next year. Additionally, the police and fire departments requested three additional radios.

Mr. Cordrey expressed his interest in purchasing the radios imminently to avoid supply chain problems and also hoped to reap the cost saving benefits.

The other trustees came to the same conclusion. Therefore, Mr. Rozzi decided to move forward with that option.

Trustee Comments

Mr. Cordrey made a reminder about the Earth Day Mounts Park Clean- Up on Friday, April 22 from 9 until 2. He invited everyone to come out and enjoy the forecasted great weather. Mr. Cordrey announced that Pienic in the Park would taking place in a few weeks.

Mr. Sousa recapped the Easter Egg Hunt and noted the large number of families in attendance. Additionally, he thanked Ms. Nicole Earley for her proactive hard work on the Park Cleanup. He commented that she had recruited close to 60 volunteers to participate in the Earth Day event. Finally, Mr. Sousa offered congratulations to the firefighters and patrol officers that were sworn in earlier that evening. He noted it was good to see their family and fellow peers come out in uniform on a Wednesday evening. He commented the gathering was a nice testament of the current staffs' character to support the new hires.

Mr. Rozzi agreed with everything Mr. Cordrey and Mr. Sousa observed. Additionally, he stated the upcoming Friday would be the first Fireworks Friday for the Reds.

Lastly, Mr. Weber asked to speak. He reminded everyone about the upcoming road construction located on 22/3 and the entrance of Mounts Park. He mentioned entering the park would be possible on the north (South Lebanon side). This road work would take place from May 2- May 6.



On June 18 and 19, 2022, **all** Ohio residents are invited to experience Ohio's fantastic public fishing opportunities without purchasing a license. All size and daily limits apply during these two days.



FISHING REGULATION CHANGE

Changes from the previous regulations booklet are listed in red text.

The nonresident Lake Erie fishing permit is no longer required.

THE OHIO CONSERVATION CARD

The Ohio Conservation Card (a durable plastic card) is included with the purchase of a lifetime license. The card may also be purchased for \$4.00 with a multiyear license.

LICENSE REQUIREMENTS

- A fishing license is required to engage in fishing in Ohio waters.
- A fishing license is required to take frogs or turtles on public and private property.
- Persons fishing in privately owned ponds, lakes, or reservoirs that are open to public fishing through an agreement or lease with the Ohio Division of Wildlife are required to have a fishing license.
- Persons must have their license in their possession while fishing and must show the license to anyone on request. Licenses may be displayed using a mobile device.
- Members of the U.S. Armed Forces on active duty stationed in Ohio, but not on leave or furlough, are required to purchase a resident license.

A FISHING LICENSE IS NOT REQUIRED OF PERSONS WHO ARE:

- Less than 16 years of age. This includes frogs and turtles;
- Persons fishing in privately owned ponds, lakes, or reservoirs to and from which fish do not migrate are not required to have a license to take fish;
- Giving assistance to an angler who has been issued the free mobility impaired or blind fishing license, provided the two persons together are using only one line;
- Fishing, or taking frogs or turtles, on land and water which they or their parents own, except where the land is in or borders on state parks or state-owned lakes;
- Fishing, or taking frogs or turtles, on land and water where they or their parents are tenants on which they reside, and from which they derive the majority of their income from agricultural production on that land (except state-owned lakes);
- Members of the U.S. Armed Forces on active duty while on leave or furlough;
- On June 18 and 19, 2022, all Ohio residents may fish without a license as part of Free Fishing Days.

LICENSE PURCHASING

- An Ohio resident is a person who has resided in the state of Ohio for the past six consecutive months. All others are considered nonresidents and must purchase a nonresident license.
- Licenses purchased on wildohio.gov will be emailed to the customer upon completion of the transaction. Licenses are not required to be printed as long as the image of the license may be displayed on a mobile device and presented upon request.
- Operator assistance for specific license sales is available by calling 1-866-703-1928 between 6 a.m. and 10 p.m. A \$5.50 fee will be added to the cost of the license.
- Annual fishing licenses are valid for 365 days from the date of purchase. Annual and multiyear fishing licenses are valid from the date of purchase until the expiration date printed on the license.
- Lifetime licenses and multiyear licenses may be purchased at wildohio.gov, provided an Ohio driver license or state identification is associated with the customer's account. Lifetime license buyers may also visit an Ohio Division of Wildlife office or mail in a paper application. Proof of age and residency are required at the time of purchase. A multiyear license may also be purchased at an agent location (restrictions apply). Visit wildohio.gov for more information about lifetime or multiyear licenses.

STATEWIDE REGULATIONS

These regulations apply to all public waters in Ohio where site-specific regulations are not implemented. Exceptions to these regulations include locations listed for Lake Erie and its tributaries (below), the Ohio River (pages 8-9), Site-Specific Waters (page 10-12).

LAKE ERIE REGULATIONS

These regulations apply to the Lake Erie Sport Fishing District as described here: Lake Erie and areas immediately upstream in creeks, rivers, and tributaries. The following regulations for walleye, sauger, saugeye, yellow perch, black bass (largemouth, smallmouth, and spotted), and white bass apply to the waters of Lake Erie, its embayments including Maumee Bay, Sandusky Bay, East Harbor, Middle Harbor, and West Harbor, and from where Lake Erie tributaries enter the lake upstream to the following end points:

- Arcola, Wheeler, Cowles, and Indian creeks: U.S. Route 20 bridges;
- Ashtabula River: E. 24th Street bridge;
- Black River: State Route 611 bridge;
- Conneaut Creek: Main Street bridge (downtown to Conneaut);
- Euclid Creek and Chagrin River: State Route 283 bridges;

- Rocky River: Detroit Road bridge;
- Sandusky River: Waterworks dam in Tiffin;
- Maumee River: First dam upstream (Grand Rapids, Ohio);
- Vermilion River: State Route 2 bridge;
- **Grand River:** State Route 535 bridge;
- **Cuyahoga River:** Harvard Road bridge.

The length of a fish is measured as a straight line from the utmost end of the snout with the mouth closed to the utmost end of the caudal (tail) fin when the tail fin is compressed so that the upper and lower lobes touch or overlap.

EASTERN UNIT • OHIO/WEST VIRGINIA

The eastern unit consists of Lawrence County east of South Point, and Gallia, Meigs, Athens, Washington, Monroe, Belmont, Jefferson, and Columbiana counties. West Virginia and Ohio will honor the other state's fishing licenses along their common borders on the main stem of the Ohio River, including its banks and embayments, and tributaries to the landmark location listed in Publication 404, Waterfowl Hunting and Fishing on the Ohio River (found at wildohio.gov), or call 1-800-WILDLIFE (1-800-945-3543). Boundaries for areas not listed in this publication extend to the first riffle. This agreement applies to West Virginia and Ohio residents only.



PYMATUNING LAKE REGULATIONS OHIO - PENNSYLVANIA

Either an Ohio or Pennsylvania fishing license may be used when fishing from a boat; however, a Pennsylvania fishing license is required to take fish, frogs, or turtles from the shore of the Pennsylvania side or from any island. Fish may not be filleted before the angler has completed fishing. Fish may be taken only by angling, except carp and suckers which may be taken with longbow and arrow, or spears. Special regulations apply to frogs, turtles, tadpoles, minnows, and ice fishing—see the Pennsylvania regulations for specific information.

Pymatuning Lake anglers fishing in either Ohio or Pennsylvania waters may use up to three fishing lines, whether fastened to a pole, a rod and reel, or hand-held. Anglers may use up to three hooks on each line.

SITE-SPECIFIC REGULATIONS

MAUMEE, PORTAGE, MAHONING, & SANDUSKY RIVERS

The following regulations are in effect from March 1 to April 30, 2022.

NO FISHING WITH A LINE WITH MORE THAN A SINGLE HOOK.

The line may not have a hook larger than ½ inch from shank to point, or lure having more than a single hook larger than ½ inch from shank to point. Double and treble hooks are prohibited. These regulations apply to the following areas:

- The Maumee River from the Grand Rapids Providence Dam to a line in the Maumee Bay from Little Cedar Point to Turtle Island;
- The Sandusky River from the Waterworks Dam in Tiffin to a line running ¼ mile east of and parallel to the full length of the Norfolk Southern railroad bridge in Sandusky Bay;
- The Portage River from State Route 19 to the dam at Elmore;
- The Mahoning River from the dam at Berlin Reservoir to Lake Milton.

FISHING IS ALLOWED ONLY FROM SUNRISE TO SUNSET IN THE FOLLOWING AREAS:

- The Maumee River from the Ohio Turnpike bridge to the Old Waterville interurban bridge at the end of Forst Road in Wood County, and from the State Route 295 bridge to the Grand Rapids Providence Dam;
- The Sandusky River from the Waterworks Dam in Tiffin to the northern tip of Brady's Island in Fremont;
- The Portage River from State Route 19 to the dam at Elmore;
- The Mahoning River from the dam at Berlin Reservoir to Lake Milton.

FISH FOR YOUR HEALTH

Most Ohio sport fishes are low in fat, high in protein, and can be part of a healthy diet. The Ohio Department of Health recommends limiting fish consumption to one meal per week, unless a specific advisory is listed for a water body or type of fish.

Ohio anglers typically eat two or fewer meals per month of wild-caught fishes. The

greatest amount of fish eaten in Ohio come from Lake Erie, where both sport and commercial fisheries operate. Current Lake Erie advisories indicate that it is safe to eat one meal per week of walleye, and two meals per week of yellow perch.

The Ohio Department of Health lists current guidance on safe consumption of wild-caught fish in Ohio for specific waters and fishes at odh.ohio.gov/ohfishadvisory.



STATE ENDANGERED FISH SPECIES

In an effort to protect rare native species, the fish listed below are protected in all Ohio waters and if caught must be immediately released back into its originating waterbody. **Possession of these fish is prohibited:** bigeye shiner, cisco (or lake herring), gilt darter, goldeye, lowa darter, lake sturgeon, longnose sucker, mountain brook lamprey, northern brook lamprey, northern madtom, Ohio lamprey, pirate perch, popeye shiner, pugnose minnow, Scioto madtom, shoal chub, shortnose gar, shovelnose sturgeon, spotted darter, spotted gar, tonguetied minnow, and western banded killifish.

FROG & TURTLE REGULATIONS

Reptiles and amphibians may not be taken by shooting, except green frogs and bullfrogs which may be taken with archery equipment.

TURTLE SEASON

Turtle season is open July 1, 2022 to December 31, 2022. Only snapping and softshell turtles may be legally taken. Snapping turtles and softshell turtles must have a straight-line carapace length of 11 inches or greater to be taken, and there is no daily limit. A turtle trap must be marked with the name and address or customer identification number of the owner or user. All traps must be checked once every 24 hours.


It is illegal to take, collect, or possess the eggs of snapping turtles or softshell turtles from Ohio lands or waters. See wildohio.gov for additional regulations.

Snapping turtles and softshell turtles may be taken by any method except:

- By shooting;
- Turtle traps having mesh measuring less than 4 inches on a side, unless such traps are provided with an escape ring of at least 6 inches in diameter leading out of the trap and held open at all times;
- Turtle traps placed in water having wings or leads;
- A foothold or body-gripping trap;
- Deleterious or stupefying substances;
- Chemicals;
- Smoke:
- Explosives.

FROG SEASON

Frog season is open from 6 p.m. on June 10, 2022 (the second Friday in June) to April 30, 2023. Only bullfrogs and green frogs may be taken. No more than 15 (singly or in combination) may be taken or possessed in any one day.

Bullfrogs and green frogs may be taken by any method except:

- By shooting, except with archery equipment;
- A foothold or body-gripping trap;
- Deleterious or stupefying substances;
- Chemicals:
- Smoke;
- Explosives.

TROTLINES, BANKLINES, SETLINES, AND FLOATLINES

TROTLINES

A trotline is a fishing line having suspended from it, at frequent intervals, vertical lines with baited hooks attached. Trotlines must be marked with the name and address or customer identification number of the user. Trotlines must be anchored. A trotline may not be made of wire or cable. A trotline may not be capable of being removed from the water by pulling on the shore end of the line.

No more than three trotlines are permitted in any one body of water in the Inland Fishing District. No more than 50 hooks per trotline are permitted. Trotlines may not be used within 1,000 feet downstream of any dam. All trotlines must be checked once every 24 hours.

A special trotline license is required in the Lake Erie Fishing District. This license may be obtained at the Sandusky Fisheries Research Unit, 305 East Shoreline Drive, Sandusky, Ohio 44870 (phone: 419-625-8062).

Trotlines may be used only in:

- Streams;
- Mosquito Lake north of the causeway and south of a line of buoys designating the wildlife refuge;
- Charles Mill Lake north of State Route 430;
- Clendening Lake east of State Route 799;
- Seneca Lake south of State Route 147;
- Tappan Lake above the gas line causeway and State Route 646;
- Atwood Lake north and east of State Route 542 North at Dellroy;
- Piedmont Lake in sections 11 and 12 of Kirkwood Township;

- Wills Creek Lake, except in the area directly in front of the Muskingum Watershed Conservancy District boat landing;
- Berlin Lake south and west of State Route 225;
- The inland part of Sandusky Bay commonly called Muddy Creek Bay;
- The area of Grand Lake St. Marys bounded on the west by Prairie Creek, on the east by Big Chickasaw Creek, and on the north by a line of buoys extending east to west between Big Chickasaw and Prairie creeks. Trotlines may not be set in channels or across the mouths of channels or streams in Grand Lake St. Marys.

BANKLINES OR SETLINES

A bankline or setline is a fishing line attached to the bank. Banklines or setlines may be used to catch turtles and fish. The name and address or customer identification number of the user must be attached to each line. The maximum is 50 lines, each having a single hook (not a treble hook). The lines must be attached to the shore above water, but not to a boat, dam, dock, pier, pole, rod, or wall. No more than six banklines or setlines may be used in Ohio's public waters less than 700 surface acres in size. All lines must be checked once every 24 hours. All lines must be removed after completion of use.

FLOATLINES

A floatline is a fishing line suspended in the water under a float. Floats may not be made of glass or other shatterable material. Floats must bear the name and address or customer identification number of the user. Floats must be freely adrift and be attended by the user at all times. A floatline may only have one single hook (not a treble hook). It is unlawful to set, use, or maintain more than six floatlines in all public waters of the state of Ohio less than 700 surface acres in size.

Floatline or jug fishing is permitted in:

- All streams;
- Sandusky Bay west of the Conrail Railroad bridge;
- Berlin Lake south & west of State Route 225;
- Mosquito Lake north of the causeway and south of a line of buoys designating the waterfowl refuge;
- Charles Mill Lake north of State Route 430;
- Clendening Lake east of State Route 799;
- Seneca Lake south of State Route 147;


- Tappan Lake above the gas line causeway and State Route 646:
- Atwood Lake north and east of State Route 542 north at Dellroy;
- Piedmont Lake in Sections 11 and 12 of Kirkwood Township;
- Wills Creek Lake, except in the area directly in front of the Muskingum Watershed Conservancy District boat landing;
- All public waters, except where prohibited by the owner in authority.

GENERAL INFORMATION

- It is unlawful to buy or sell any fish taken from any waters in the state where an Ohio fishing license is required, regardless of the method of take. Exceptions apply for a commercial fishing license or bait dealer permit.
- It is unlawful for the public to tag and release fish into any public water area.
- It is unlawful for any person to possess a fish in any form or condition other than whole while, on or unloading the fish from, a boat while wading, or while fishing on or in any waters in this state where a fishing license is required.
- It is unlawful to transport and introduce any aquatic species (fish, invertebrate, plant) from one body of water to another.
- Fillets are required to be kept whole until an angler reaches their permanent residence, or until the fish are prepared for immediate consumption. Frozen fish are required to be transported in such a way that the fillets can be easily identified and counted. This does not apply to anglers with a receipt from a fish cleaning house or charter captain which states the date, number, and type of fish possessed. Fish must be transported whole or as a complete fillet while returning from the Lake Erie islands on a commercial ferry boat.
- Forage fish, rough fish, and game fish that do not have a possession or length limit on those waters may be cut up and used for bait, provided that the skin or head of the bait is intact so that the species is visually identifiable.
- It is unlawful to take the following fish by any method of using the hands (including noodling) statewide: bullhead, channel catfish, flathead catfish, and blue catfish; coho and chinook (pink salmon); brown trout, rainbow trout, and steelhead trout; as well as walleye and sauger in the Maumee and Sandusky rivers.

CLAMS, MUSSELS, & MUSSEL SHELLS

Clams, mussels, or mussel shells may not be taken, possessed, or collected for any purpose.

FREE LICENSE

- Ohio residents born on or before December 31, 1937 may obtain a free license at any license outlet, or online at wildohio.gov.
- The following Ohio residents are also eligible for a free license, but must submit a formal application, which is available by calling 1-800-WILDLIFE (1-800-945-3543):
 - Persons who are mobility impaired and require the assistance of another person to cast and retrieve
 - Holders of veteran license plates displaying the international wheelchair symbol
 - Certain veterans who are permanently disabled
 - Residents of state and county institutions
 - Former prisoners of war.

SOCIAL SECURITY NUMBER REQUIREMENT

Any customer who applies for a license is required to provide their Social Security Number (SSN). Federal Statute 42 requires the SSN of any individual to whom the state issues a recreational hunting or fishing license. Applicants who do not have an active SSN must affirm their status at the time of application. Applicants must also declare their residency and provide their full name, date of birth, gender, address, height, weight, hair color, and eye color. Once provided and recorded in the licensing system, applicants will only be required to update their information on file if it changes.

BAIT

It is unlawful for any person except licensed bait dealers to possess more than 100 crayfish, or in combination 500 crayfish, minnows, and other baitfish. A bait dealer's permit is required of persons buying or selling minnows, crayfish, and hellgrammites. This permit may be obtained at wildohio.gov.

It is unlawful to release any baitfish or minnow into waters of the state from which it did not originate.

FORAGE FISH

Forage fish means freshwater drum (sheepshead), common carp, grass carp (in waters not stocked by the Ohio Division of Wildlife for vegetation control, as indicated by signs), bighead carp, silver carp, black carp, quillback, suckers, bowfin, gar, buffalo, gizzard shad, and goldfish. These species may be taken by any method except by means of explosives, poisons, firearms, electricity, chemicals, nets (other than cast nets), seines, traps, or by snagging within 1,000 feet downstream of a posted dam or dam on the Muskingum River (see SNAGGING for additional information). Gizzard shad and rainbow smelt may be taken with a minnow seine, minnow dip net, or hand landing net.

ICE ANGLERS

Ice anglers may use holes no larger than 12 inches in diameter. On Lake Erie, ice anglers may use holes no larger than 12 inches in width. Ice anglers may not use more than six tip-ups and two rods per person. All shelters and tip-ups must display the name and address or customer identification number of the owner or user.

A tip-up means a device consisting of a hook and line attached to a spring or other device which is capable of raising a small flag or other signaling device when a fish is biting or is hooked.

ARCHERY ANGLERS

Archery anglers may use bows of any draw weight. A fishing license is required. Archery equipment may be used to take bullfrogs, green frogs, and forage fish.

SNAGGING

Snagging with a hook to pierce and hook a fish in a part of the body other than the inside of the mouth is illegal for all fish except forage fish. In Lake Erie, it is also illegal to snag freshwater drum. Snagging any species of fish is illegal from September 1 to April 30 in the Ashtabula River, Chagrin River, Grand River, Rocky River, Vermilion River, Arcola Creek, Conneaut Creek, Cowles Creek, Euclid Creek, Indian Creek, Turkey Creek, and Wheeler Creek. It is illegal to snag any species of fish during any time of the year in the Ohio River. Snagging is prohibited within 1,000 feet downstream of any dam on the Muskingum River. Snagging is prohibited within 1,000 feet downstream of a dam where signs are posted. Hooks used for snagging may not be larger than 5/8 inch from shank to point.

FISHING LINES

Anglers may use a maximum of two fishing lines, whether fastened to a pole, a rod and reel, or hand-held, except for Lake Erie, the Ohio River, and Pymatuning Lake, as listed on pages 7, 8, and 11, respectively. Anglers may use up to three hooks on each line, except as provided in the Ohio Administrative Code.

CAST NETS

Forage fish and minnows may be taken with cast nets. All other fish are required to be released immediately unharmed. It is unlawful to use a cast net with a square mesh less than ¼ inch or larger than 1 inch on a side, or with a diameter greater than 10 feet. It is illegal to use a cast net within a distance of 1,000 feet downstream from any dam posted with Ohio Division of Wildlife signs indicating cast net use is prohibited.

MINNOW SEINES AND DIP NETS



FIRST AMENDMENT TO CONCESSION STAND LEASE

This FIRST AMENDMENT TO CONCESSION STAND LEASE (this "Amendment") is entered into as of this _____ day of _____, 2022 (the "Effective Date") by and between HAMILTON TOWNSHIP, WARREN COUNTY, OHIO (the "Township") and BILL BARNILL ("Lessee") (the Township and Lessee may each be referred to herein as a "Party" and collectively as the "Parties).

- A. The Township owns certain real property on which it operates a public park commonly known as "Testerman Park," located at 8373 Maineville Road, Maineville, Ohio 45039 (the "Park").
- **B.** The Township maintains a concession stand in the Park used for the provision of food and refreshments to patrons of the Park during certain seasonal months (the "Concession Stand").
- C. The Township and Lessee are parties to a certain Concession Stand Lease, dated May 4, 2022, whereby Lessee leases the Concession Stand from the Township (the "Lease"). The Parties desire to amend the Lease pursuant to this Amendment.
- 1. <u>Lease Term</u>. The Lease Term is hereby amended to be effective from April 1, 2022 until July 31, 2022. All terms and conditions set forth in the Lease shall continue to govern the Lease throughout the new Lease Term, unless expressly modified by this Amendment.
- **Rent.** The "RENT" provision set forth in the Lease is hereby removed from the Lease in its entirety and replaced with the following:

Lessee shall pay rent to the Township during the Lease Term, in the form of a certified check or money order, in the total amount of Eight Hundred Fifty Dollars and 00/100 (\$850) as follows:

- (i) \$100 to the Township on or before April 29, 2022;
- (ii) \$250 to the Township on or before May 31, 2022;
- (iii) \$250 to the Township on or before June 30, 2022; and
- (iv) \$250 to the Township on or before July 29, 2022.
- 3. <u>Insurance</u>. Lessee shall keep and maintain at all times during the Lease Term general liability insurance coverage for bodily injury and property damage, with insurance companies authorized to do business in Ohio, and within limits satisfactory to the Township. Lessee shall furnish proof of its maintenance of the insurance coverage required herein within seven (7) days of the Effective Date.
- 4. <u>Mobile Food Vendors</u>. The Township shall not contract with, or arrange for, any mobile food vendors to offer food or refreshments in the Park at any time during the Lease Term; provided, however, the Township may contract with, or arrange for, mobile food vendor services in the Park, in addition to services offered by Lessee, in connection with any Township-sponsored public event.
- 5. <u>Miscellaneous</u>. Any provision of the Lease which is not expressly modified herein shall continue to apply and govern the Lease during the amended Lease Term. This Amendment sets forth the entire agreement between the Parties with respect to all agreed modifications to the Lease. The Lease, as amended herein, constitutes the entire agreement and understanding between the Parties with respect to Lessee's lease and use of the Concession Stand during the Lease Term. Any further modification to the Lease shall only be valid and binding if set forth in a writing signed by both Parties.
