Mr. Pegram stated we reached an agreement with the IAFF Local 4055 which represents our Full Time Firefighters. They have already voted and approved. It's a 3 year contract. We had a great negotiation. Currently our full time EMT's pay rate is very close to the Paramedic pay rate. Typically there is a larger gap to incentivize people to go to Paramedic School. What we did with contract is lower the EMT pay to give us that incentive. It is still a competitive rate. The first item is the actual agreement. The second is entering into an MOU with the Union that allows us to higher new employees at this rate in 2023 because the contact doesn't go into effect until 2024.
