Mr. Ray Warrick Township Administrator explained the two pieces of the bell tower, the tower or cupola and the bell itself. Ch. Reese stated the bell has been placed on cypress wood donated by Richard Oeder, Firefighter Dusty McCleese and others have constructed the stand or platform and will complete it with a plaque telling the history later this year. It will remain on display at Station 76.

Mr. Warrick asked the trustees to approve Resolution # 16-0420, declaring certain property as surplus, of no value and authorizing its disposition. The bell tower or cupola is in poor condition and unable to be reused. The family of the man who constructed the cupola wishes to repair it and display it at their family farm.
