## Office of Public Works 08/02/2023 Trustee Meeting

The following motion(s) is/are requested by the Board of Hamilton Township Trustees from the Director of Public Works in concurrence with Township Administrator:

Motion to approve a contract with Contractors Inc. for repairs to the Public Works Garage at a cost not exceeding \$56,260.50.

The metal building where most of our fleet is stored needs significant repairs to extend the life cycle and use of the building. The majority of the damage is rusted (holes in) the metal siding and gutters as well as rotten wood around door frames etc.

Although the total cost of these repairs is almost \$57,000, we are splitting the repairs between 2023 and 2024 budget years and different sides/portions of the building.

We received two other bids, one for \$62,560 and the other for \$63,214.86.

The 2023 cost is \$26,517.16 and will include the following:

- Remove old siding and trim.
- Replace siding with new panels.
- Install new Trim.
- Remove and replace existing/new gutters.
- Remove and replace all rotten wood around doors.
- Repaint Garage Doors
- Install new Vinyl trim around garage doors.

This is a 2023 budgeted item and phase 2 was/is budgeted in the July Tax budget for 2024.
